We are in search of a H.O.P.E Transition Coordinator who will build and maintain relationships with residents called "class members" and staff at select skilled nursing facilities. Will also partner with other providers and coordinate the activities needed to transition clients from skilled nursing facilities into the community.

We are looking for someone who will bring their experience and passion to support the independence and well-being of our clients.

DUTIES AND RESPONSIBILITIES:

- Develops comprehensive, person-centered service plans for class members and monitors and updates service plans according to program guidelines
- Interviews class members and nursing home staff, and reviews facility and other records to identify strengths, developmental areas, and independent living skills
- Completes needed tasks for class members in preparing for moving into the community, including assistive technology referrals, DON requests, durable medical requests, obtaining free/reduced fare cards for class members, and makes referrals to other community agencies as appropriate
- Visits class members in the nursing home once a month
- Coordinates with family members and other personal contacts, as needed
- Reviews nursing home and medical records
- Coordinates with managed care organizations (MCOs) on behalf of class members
- Assists class members with filling out supportive living program applications and accompanies them on tours of supportive living programs
- Assists class members with obtaining documents from the Social Security office and Secretary of State's office
- Accompanies class members to select appointments
- Support other areas of the program, as needed
- Collaborates with partner agencies to facilitate all aspects of the transition
- Follows all program standards and procedures

QUALIFICATIONS:

- Bachelor's Degree (BA, BSW) in social work, counseling, psychology, or related field
- Licensed Clinical Social Worker (LCSW) or Licensed Clinical Professional Counselor (LCPC), preferred
- Minimum of 1 year experience in providing social services for older adults
- Experience in working directly with clients with severe mental health conditions, drug/alcohol abuse and/or complicated physical illness preferred
- Excellent written and oral communication skills needed, with demonstrated ability to engage clients
- Computer skills required: Microsoft Office Suite; ability to learn proprietary program databases
